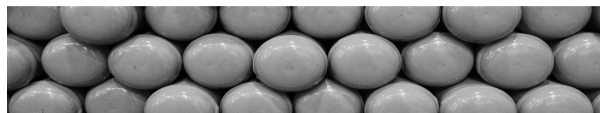

### Handling - Storage - Disposal

Gas-based containers cannot be directly exposed to sunshine rays, nor be closed to heat sources or in places where temperature can reach 50°C or more.

Ensure proper ventilation (natural or forced) where cylinders are stored and/or used.

Carefully handle the cylinders thus avoiding violent collisions between them or against surfaces, as well as falls and other mechanical strains susceptible to damage their integrity.

Completely empty bottle should be disposed with other ferrous metals or according to local regulation

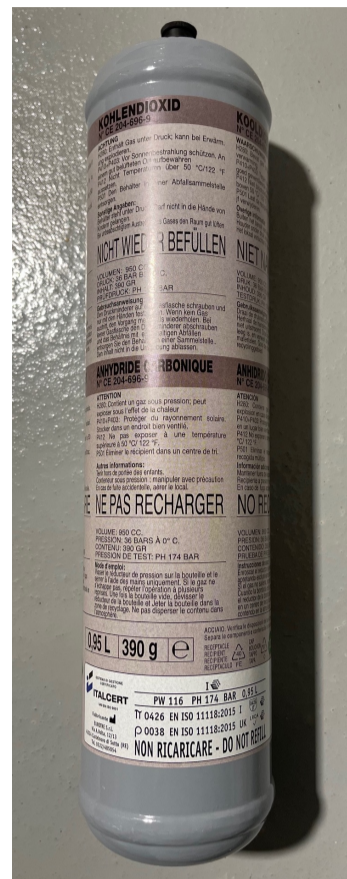
